

**WESTCHESTER PUBLIC LIBRARY
RESOLUTION NO. 2018-2
RESOLUTION ESTABLISHING PREVAILING WAGES**

Whereas, the State of Illinois has enacted “An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works” being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

Whereas, the aforesaid Act requires that the Westchester Public Library investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Westchester Public Library employed in performing construction of public works, for said Westchester Public Library; and Now, therefore, be it ordained by the Westchester Public Library, Cook County, Illinois, as follows:

SECTION 1

To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works” the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the Westchester Public Library is hereby ascertained to be the same as the current prevailing rate of wages for construction work in the Cook County area as determined by the Department of Labor of the State of Illinois, a copy of that determination being attached hereto as Exhibit “A” and incorporated herein by reference. The definition of any terms appearing in this Ordinance which area also used in the aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the Westchester Public Library to the extent required by the aforesaid Act.

SECTION 3

The Westchester Public Library shall publicly post or keep available for inspection by any interested party in the main office of the Westchester Public Library this determination of such prevailing rate of wage.

SECTION 4

The Westchester Public Library shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5

The Westchester Public Library shall promptly file a certified copy of this Resolution with the Department of Labor of the State of Illinois.

SECTION 6

The Westchester Public Library shall cause a notice to be posted on the website of the Westchester Public Library including a link to the Illinois Department of Labor's prevailing wage chart for Cook County in Illinois. Said notice shall conform substantially to the notice attached hereto. Such posting shall constitute notice that this is the determination of the Westchester Public Library and is effective as of the date adopted.




